- 1 Free IDN domain name with registration period of 1 year only will be applicable to new creates of both second level and third level .IN registrations for all tenures:
 - Second Level .IN registrations e.g. example.in
 - Third Level .IN registrations e.g. example.co.in
- As per our recent announcement, all .IN accredited Registrars will have access to IDN zones by default. There is no need to sign any additional documents to get accredited for IDNs. Please contact techsupport@registry.in if you have any further questions regarding access to IDNs.

- Registrars are required to offer “Free IDN domain” to the Registrants in accordance with the program. Same is suggested for promoting the program on customer interface/website. **Please email a screenshot of your website displaying the “Free IDN domain” promotion by 5 January 2021 to programs@registry.in and registry@nixi.in for verification of initiating this process.**
- Free IDN domain names will be provided as an upfront discount after submitting proof as mentioned above. After submitting the requested proof, we will reimburse the cost of IDNs provided for Free between 00:00:00 (IST) 1 January 2021 i.e. 18:30:00 (UTC) 31 December 2020 and the upfront discount implementation date.
- Additional amount of INR 15 per Free IDN domain name provided to Registrants will be given as a reimbursement upon meeting the requirements mentioned below.
- Registrars are required to submit proof of providing Free IDN domains in the following format to claim the additional INR 15 amount.
